- 2. Quorum CRWEF Vice Chair **Crystal Greenlay** confirmed Quorum
- Welcome and Introductions President Nancy Sinclair gave welcoming remarks and introduced Board of Directors: Nancy Sinclair, Crystal Greenlay, Brian Taylor, Nicole Anderson, Koby Godwin, Keith Turner, James Hardy and Jay Wong and special guests/IEC members and Past CRWEF Presidents: Dawn McDougall, Stewart Anderson, Gord MacNair,
- 4. Special Business-Donation Announcements President **Nancy Sinclair** requested that anyone that wished to make a donation to CRWEF to come forward at the IRWA AGM.
- 5. Aapproval of Minutes: It was noted by the CRWEF board that the minutes from the 2021 AGM were not sent out in advance of the meeting to the general membership. After a brief discussion of options, including consideration to read them aloud in their entirety, it was decided that the draft minuets of the 2021 AGM would be posted online, but acceptance by the general membership would be at the 2023 AGM, along with the minutes of the 2022 meeting.
- 6. Business from Minutes:
 - a) Treasurer's Report: Presented by **Brian Taylor**, Treasurer provided a copy of the Foundation's Balance Sheet as prepared by the accounting firm of Jeffrey J. O'Rourke Professional Corporation reflecting transactions occurring up to March 31, 2022.

At the 2017 Annual General meeting discussion took place to have a formal audit every 3 years. Accordingly, the next audit will take place in the fiscal year 2023/24

a) Scholarship – **Nancy Sinclair, President** advised that this year's \$2500 scholarship award – 4 members assisted in the review of the applications. Thanks go out to Nancy, Koby, Brian, & Nicole for their participation.

The scholarship was awarded to Avry Krywolt of Airdrie, Alberta.

A valedictorian of his school, Avry will be attending Simon Fraser University in the upcoming fall term majoring in Sustainable Energy Engineering. He hope to use his degree and knowledge in the engineering of sustainable projects in developing countries. Avry has been very actively involved in the Alberta Your Leader's for

Environmental Education with the missions of making climate education a priority for schools across Alberta. His experience in speaking on behalf of the organization has led him to the development of a successful climate podcast called *Innovating a Bright Future* which is releasing its third season this summer.

Introduction of New scholarship program: CRWEF representatives have attended the Region Forums this spring with a view of introducing a new member focused scholarship program. The proposed program will include:

- Introduce the partnering of CRWEF with the Canadian Chapters by providing a commitment of \$3000 per year to each of the 7 Canadian Chapters for each of the next 3 years
- Chapters would be welcome to match or add to the scholarship amount
- Criteria will be based on member in good standing, seeking a designation through the IRWA. Chapters may further define criteria for their members but the intent is to make available to all members seeking designation (not recertification)
- Chapters to be responsible for the receipt and review of member applications

In 2022/23, the Canadian Right of Way Education Foundation will create a member scholarship program, at a value of \$3k per Canadian chapter. The criteria for award will be determined by the CRWEF executive with input from the IRWA Region executive and the IRWA nominations and elections committee.
